## ABSTRACT

As people become more aware of the advantages of a balanced diet, there has been an increase in the demand for automated food recognition systems. Such systems can not only predictably identify food products, but they can also estimate nutritional values, making them especially useful for dietary appraisal and preparation. This can benefit patients with various dietary requirements as well as healthier people by preventing nutrition-related diseases.

With the help of AR technology, we were able to develop our project in such a way that the user doesn't have to manually enter information about the nutrients and calories present in the food item they want to eat. Instead, a 3D image of the food item was provided, and the food item was detected, identified, and its nutrients and calories were stored in a database. This allowed the user to choose a healthy diet without having to manually enter information about the nutrients and calories present.

The main agenda of our model is, to determine the estimate the calories per food item. We used Yolov3 and Yolov5 as our primary algorithm. Our algorithm analyse, the image and create boundary boxes for every image and extract the unwanted image. The Previous dataset is used and according to that, our model analyses the image and produces the estimated calories. Thereby, he/she can understand, and use it for daily purpose.

This project has several advantages as well as disadvantages too, lets talk about the disadvantages first. The main disadvantage we faced is , image quality where our model took several attempts to analyse the picture quality. Secondly, use of large dataset , were our model took several attempts and pre-processing time was slow, after several attempts. model got adapted to the data. There are advantages too, calories will be provided just by a single picture at very less processing time. This project is invented for the people who are suffering from major obesity problems and for the people who are having lack of knowledge to maintain a healthy diet.

# CHAPTER 1 INTRODUCTION

#### **1.1 INTRODUCTION**

Obesity has grown significantly over the past ten or so years, globally. The use of meal logging and calorie analysis to combat obesity has been the subject of growing research. Numerous food management programs with picture recognition that automatically record meals have emerged as a result of an increase in healthy lifestyles. It's critical for someone to keep track of their daily caloric intake if they want to live a healthy lifestyle. In order to calculate comparatively precise count of calories from photographs of products, the research attempts to combine modern object detection algorithms with image analysis techniques. The method used here uses mathematical calculation of the feature that are taken from the images of the food items using segmentation to finally compute the calorie-count of the food.

The model developed in this research estimates food calories from photos of food items. We are able to identify food from the various data-sets of Indian cuisine and compute the necessary meal calories by utilizing YOLO You Only Look Once for object identification and Image segmentation for calorie calculation.

Digital classification of food, for instance, informs users about their everyday calorie intake and dietary needs. The goal of this effort is to create a smart-phone application that can capture photographs of meals in real time and analyse them for calories so that individuals can modify their eating habits and live healthier lives.

The project employs YOLO algorithm and image segmentation in this study to identify and estimate the caloric content of food products, respectively. A real-time object detection algorithm is called YOLO (You Only Look Once). It determines how the code will identify the items in the image. It takes one quick look at the image before scanning the network to find the object. To calculate the number of calories in the found food item, the image segmentation method from image processing is applied.

#### **1.2 STUDY**

Food detection and calorie estimation are areas of active research in the field of computer vision and machine learning. These technologies aim to automate the process of tracking one's diet and caloric intake, which can be helpful for individuals looking to manage their weight or maintain a healthy lifestyle.

A lot of research papers have focused to develop algorithms for Food and Calorie detection using Computer vision techniques. One of the papers have used a data-set of more that ten thousand food item images for training a Deep Neural Network to identify and then classified it into different types of food items. This Deep Neural Network had reached an accuracy level of more than 80% in correct classification of the respective food item and was also capable in estimating the calories content as well with an error percentage of 10% only.

An app for smart-phones was utilized in a different study to gather pictures of food and calculate the meal's caloric content. To identify the foods in the photograph and calculate their caloric content, the app combined image processing and machine learning techniques. According to the study, the software could predict the meal's calories with an accuracy of between 10% and 20% of the real value.

Despite the promising results of these studies, there are still challenges to overcome in developing accurate and reliable food detection and calorie estimation technologies. Factors such as lighting, portion size, and food composition can all affect the accuracy of these systems, and further research is needed to improve their performance in real-world scenarios.

#### **1.3 PROBLEM STATEMENT**

- In the fast-paced world, obesity has become a major health issue to the human beings. BMI defines the obesity when it is greater than 30kg/m. Obesity leads to many diseases like high cholesterol, liver failure, knee problems, diabetes and sometimes cancer. When the patient eats healthy food, the obesity can be controlled.
- The obesity problem can be addressed when there is a system that monitors the food consumed by the patient in treatment of obesity. Many of the people find it difficulty in monitoring their food intake periodically, due to less knowledge in nutrition.
- In this chapter, identification of food type is made and estimation of calorie is done by using MLP and proposes the results. Single food items types were considered previously, but here mixed food item types are considered.
- Region of interests is used to identify the mixed food item type. The next step includes feature extraction process. The extracted feature Image is fed into MLP classification to classify the image. The volume of food is used to calculate the calories present in the food. The implementation is done by taking 1000 fruit images containing 6 food classes with good accuracy. The automatic dietary control is made available for the diabetic patients.

#### **1.4 MOTIVATION**

- According to current data, 650 million people worldwide are obese, and nearly 1.97 billion are overweight. Obesity-related deaths were predicted to number 2.8 million. Because of the consumption of energy-dense food (i.e., bad eating habits), a sedentary lifestyle, a lack of fitness care facilities, and monetary constraints, the developing world faces a huge risk of weight problems and their negative consequences (i.e. diabetes, ischemic coronary heart disorder, etc.). Weight problems affect more than 135 million people in India.
- In India, the occurrence of weight problems varies by age, gender, location (geographic and socioeconomic), and so on.
- The incidence rate of central weight disorders ranges from 11.8% to 31.3% and 16.9% to 36.3%, respectively, according to the 2015 Indian Council of Medical Research. In India, issues with belly obesity pose a significant risk for cardiovascular disease. Women are more likely than men to be obese, according to numerous research. One of the most expensive scientific and financial costs for the government is weight-related disorders. By raising public knowledge of weight issues and how they affect fitness, they can be prevented. Governmental bodies ought to advocate for the benefits of a healthy lifestyle, which includes good diet and exercise practises.
- The purpose of the above words is to explain the superiority of weight problems in various Indian areas and to pique readers' interest in the difficult areas.

# CHAPTER 2 LITERATURE SURVEY

A method of estimating calories for dietary assessment using image analysis had been described by Tatsuya Miyazaki, Gamhewage C[1] de Silva, and Kiyoharu Aizawa [2]. They created a dataset with 6000 photos that was made up of food log calorie counts calculated by the nutritionist. Multiple alternatives, including Correlograms, colour Histograms, and SURF options, were used to compare the food image to the food log dataset.

A food calorie and nutrition measurement method that assisted patients and dietitians in controlling daily food consumption was provided by Parisa Pouladzadeh [3], Shervin Shirmohammadi [4], and Rana Al-Maghrabi [5]. According to the report, a smartphone application that measures calorie and nutritional content by taking photos of food before and after consumption would be developed.

YOLO, a unified paradigm for object detection, had been introduced by Joseph Redmon[6], Santosh Divvala[7], Ross Girshick[8], and Ali Farhadi[9]. This model may be built quickly and trained using only full photos. YOLO is trained using a loss function that directly relates to detection performance, in contrast to classifier-based techniques, and as a result the complete model is trained at once.

Manal Chokr [10] and Shady Elbassuoni [11] proposed the easiest approach to estimate the calorie content of the food item by estimating the size of the item by passing the compressed image through a regressor (directed towards eatables like pizzas, doughnuts, chicken, and sandwiches).

YOLOv2 and YOLO9000, real-time detection systems, were introduced by Joseph Redmon[12] and Ali Farhadi[13]. Comparatively speaking, YOLOv2 is quite quick. A real-time framework

called YOLO9000 allows for the classification and detection of over 9000 different item categories.

Sujata Chaudhari [14], Nisha Malkan [15], Ayesha Momin [16], and Mohan Bonde [17] all used YOLO to quickly find things. In this essay, YOLO will be addressed as a modern strategy.

for accurate object detection with a high accuracy. This study explains how accuracy increased during the training procedure. They have discussed the development of CNN in this work, and object detection is carried out with the use of YOLO and CNN.

The major goal of this study by Alexey Bochkovskiy [18], Chien-Yao Wang [19], and Hong-Yuan Mark Liao [20] is to construct an object detector that operates quickly in production systems while maximising for parallel calculations. An effective and potent object detection model has been created by them. Modern methods are improved to be more efficient for training on a single GPU. Numerous features have been confirmed to increase the accuracy of the classifier and detector.

# CHAPTER 3 PROPOSED SYSTEM MODEL

### **3.1 METHODOLOGY**

The dataset obtained consists of infinite food images and also the images are belonged to various classes such as Apple , Banana , Orange , Pizza , etc. Our model will be trained in such a way that, it can calibrate the object , the images placed near the webcam.

Image cropping, resizing is the main agenda of our model and ensures that unnecessary parts of the images will be deleted. The graphical image annotation tool i.e. a tool name labelling is used for creating boundary box or rectangular box around the object in the image. The format is pascal voc.

Yolo is a algorithm used for object detection. Yolo's agenda is to used a single neural network to the image, later it classify the images into several regions and predicts that the bounding box applies for each possible region. Therby our model is capable for selecting multiple objects in a single image and able to predict multiple bounding boxes and class probabilities for those boxes.

#### **3.2 MACHINE LEARNING TECHNIQUES**

Convolutional neural networks (CNN) are often used in YOLO set of rules to detect gadgets in real time. To discover gadgets, the set of rules requires only a single forward propagation via a neural network, as the name suggests. This method predicts the entire picture in a single set of rules. The CNN is used to predict a large number of classes.

#### **3.2.1 Intersection Over Union (IOU)**

Intersection over union is applicable for overlapping of boxes. The measure to calculate the accuracy of the object detector is to apply IOU, the following parameters are required.

- The ground truth bounding boxes
- The predicted bounding boxes IOU= Area of overlap / Area of Union

#### **3.2.2YOLO V3 NETWORK**

The YOLOv4 network consists of three parts :

#### a) Backbone

The feature extraction architecture is referred to as the backbone. It is a convolution neural network (CNN) that mixes and creates picture features at various granularities. The backbone distinguishes the many YOLO iterations. CSPDarknet53 is utilized in YOLOv4. Cross-Stage-Partial connections are known as CSP.

#### b) Neck

The dense prediction block's neck block serves as an additional layer between the backbone and the head. The YOLOv4 employs updated Spatial Pyramid Pooling (SPP), modified Spatial Attention Module (SAM), and modified Pan Aggregation Network (PAN) [10] to add additional information in a layer. In order to transfer image features forward for prediction, a succession of layers must be used.

#### b) Head

Bounding boxes are located using the head block, which is also used to categorise the objects in the image. It evaluates the neck block's features, finds the bounding box, then sorts it into distinct classifications.

#### 3.2.3 Convolutional Neural Network

An image's objects can be found and classified using the Convolutional Neural Network (CNN), a feed-forward neural network. It also goes by the name ConvNet. An input, an output, and several hidden layers make up a convolutional neural network. Convolutional, pooling, fully connected, and normalisation layers make up a CNN's hidden layers. RELU, which is an activation function, is also one of them.

In CNN, each image is displayed as an array of pixel values. It is a network that can take an image as input, give distinct items in the picture weights, and distinguish between things in the image. Compared to other classification methods, CNN requires substantially less pre-processing. Convolutional neural networks are tasked with converting images into a format that is simpler to comprehend while retaining the elements required for making accurate predictions.

#### **Fully Connected Layer**

Bounding boxes are located using the head block, which is also used to categorise the objects in the image. The Fully Connected (FC) Layer is made up of the weights, biases, and neurons that link the neurons of two separate layers together.

The final few layers of the CNN design are these layers, which are positioned before the output layer. The input images from the preceding layers are flattened and supplied to the Fully Connected layer in this layer.

The flattened vector is then put through more Fully Connected layers, which is where mathematical operations are typically performed. This is the stage where the classifying process starts.

#### **3.3 ALGORITHMS USED**

#### 3.3.1 Yolo v1

YOLO (You Only Look Once) is the set of guidelines that we've in use in our project, because it is able to anticipate devices in real-time, this set of rules increases the rate of detection superior precision.

YOLO is a predictive strategy that offers precise result with little in the way of background error. acquiring skills Due to the rules' excellent learning capabilities, it is possible for them to analyse the models of devices and use them in item detection.

#### 3.3.2 Yolo v3

It is a supervised learning technique that performs object detection in real time. CNN are classifier based systems that can process input images as structured arrays of data and recognized based systems and recognize patterns between them. It allows model to look at whole image at at time. First, it separate images into a grid, predict some boundary boxes, each boxes has confident score of how accurate it assumes that prediction should be and detects only one per bounding box. The bounding boxes are generated by clustering the dimensions of the ground truth boxes from the original datasets to find the most common shapes and sizes.

Thus, YOLOv3 has more accuracy than its predecessors, but it is very slow while training data. The primary contribution of YOLOv5 is the conversion of the Pytorch framework for Darknet research. The Darknet framework is written mostly in C and allows excellent control over the network's coded functioning. Low-level language control is advantageous for YoloV3 and Yolov5.
